Important Dates:

- July 1 – August 30:** Submission of images (see details below)
- September 8-10:** Notification of selected works via email
- September 19-22:** Delivery of work
- October 2:** "Illiart" opens
- October 5:** Opening Reception and Presentation of Awards 1:00 p.m. to 3:00 p.m.
- October 26:** "Illiart" Closes
- October 31 – November 3:** Pick up work

Eligibility and Media:

- ❖ All artists 18 and over and living in the state of Illinois are eligible
- ❖ All media is eligible, except **photography**, film/video, oversized works or special installations. **PLEASE NOTE: WE WILL NOT BE ACCEPTING PHOTOGRAPHY THIS YEAR.**
- ❖ Artwork will be judged on creativity, originality, technique, skill, and presentation, and must be the artist's own work
- ❖ **Entries will be juried by independent jurors (to be announced).**
- ❖ Awards: Best of Show, 1st, 2nd and 3rd Place and Honorable Mentions.

Entry and Online Process

Please read all instructions before beginning entry process

Required Artwork Information for each entry

- ❖ **Title**
- ❖ **Medium**
- ❖ **Framed art sizes in inches** (height x width x depth)
- ❖ **Sale Price:** All artwork must be available for sale. Art that is sold will remain on display until the end of the exhibit. Payment for any work sold during the exhibit will be made to Gallery Seven. The Artist sets his or her own prices. A 30% commission will be deducted from the artist's price and Gallery Seven will pay the artist within 45 days of the exhibit's closing. Gallery Seven will collect sales tax on all sales.

Digital Image File Format:

- ❖ All entry images must be in .jpg format, 72 DPI - sized at 3000 pixels on the longest side. Your entry is not complete until images, entry form and payment have been received.
- ❖ File Name: Artist's Last Name_First Name_Title (Please do *not* place your name into the digital image) Example: Smith_John_Trees
- ❖ Email your entry images as attachments with your entry form (*please do not send links to Google Drive documents or Dropbox, Apple I- Cloud, etc.*) to **g7illiart@gmail.com** (subject line: Illiart) or mail a CD with images, with your entry form, to address above, postmarked by August 31. Entry CD/DVDs will be destroyed.

Entry Fee: One \$35 nonrefundable fee entitles each artist to submit **up to five** entries. (One additional image will be accepted for each 3D piece at no extra cost.)

❖ Pay entry fee:

- 1)** by check or money order payable to Gallery Seven, sent to the address above **or**
- 2)** in person at the Gallery **or**
- 3)** with a credit card on our website **www.galleryseven.net** (via PayPal)

Guidelines:

- ❖ All entries must be of original design, suitably framed with hanging wire and bumpers and be thoroughly dry.
- ❖ MAXIMUM SIZE (including frame) – No taller than 48", no wider than 36"
- ❖ Representatives of Gallery Seven may photograph artwork or exhibit and use the images for promotional purposes.
- ❖ The artist must work and live in Illinois, but the artwork subject matter does not have to be about Illinois.
- ❖ All entries must **not** have been previously submitted to or shown at Gallery Seven.
- ❖ Accepted works must remain on display for the duration of the exhibition.
- ❖ Artwork left at Gallery Seven after December 1, 2025 becomes property of Gallery Seven.
- ❖ Artwork will be judged on originality, artistic skill, use of materials – we want you to push the boundaries of your medium!
- ❖ Please do not enter any pieces that are extremely fragile or require special handling.

Delivery of Work: Work can be dropped off at Gallery Seven during normal business hours.

Shipping:

Gallery Seven will: Accept delivery from artists wishing to ship their work. Please be sure that it will arrive in time to be examined for damages and be returned for repairs, if possible. You can contact the Gallery for more information and shipping guidelines.

Gallery Seven will: Install the exhibit and staff the gallery during regular hours and special events, send invitations to the opening reception to more than 2000 people on its mailing lists, design and print posters, and send press releases to publicize the exhibit and the opening reception.

The Artist agrees to: Advertise this exhibit and the opening reception to your customers, collectors, friends and family, neighbors, the postal delivery worker and the guy who walks his annoying dog in front of your house every morning at 5 a.m., and to post a link to the Gallery Seven website on your social media platforms and artist website.
